A stamped duplicate of the application for registration showing the date received by ADGA office will be accepted on animals less than six (6) months of age. NO COPIES of the registration certificate will be accepted.

Owners having animals with open abscesses or ones close to breaking (hair missing) or any animal showing signs of pinkeye, soremouth, ringworm, or any other contagious disease will be asked to leave the fairgrounds. A vet will be on the premises for check-in, Before animals are put in pens.

THE DECISION OF THE SHOW COMMITTEE IS FINAL. BASE DATE FOR COMPUTING AGE IS JAN 1, 2011.
